REQUEST OF: NATIONAL GRID

National Grid hereby respectfully requests your consent to the locations of mains as hereinafter described for the transmission and distribution of gas in and under the following public streets, lanes, highways, and places of the Town of Braintree and of the pipes, valves, governors, manholes and other structures, fixtures and appurtenances designed or intended to protect or operate said mains and accomplish the objects of said Company; and the digging up and opening the ground to lay or place same:

To install and maintain approximately 315 feet more or less of 2 inch gas main in Wilson Ave., Braintree. From Middle St. easterly to the end of main at #25 Wilson Ave. All of which to replace and abandon the existing gas main in Wilson Ave. with the following conditions:

BELD: Engineering has reviewed the NGRID Gas Petition #16 020 Wilson Ave & Middle St.

PLEASE NOTE: BELD has multiple underground 15 kV circuits in a single concrete encased ductbank and a 115kV transmission line on Middle St in close proximity to the proposed scope of work. The 115kV line is pressurized oil filled pipe type design encased in a thermal sand material (no concrete).

NGRID Gas should contact BELD Engineering prior to excavating near the 115kV transmission line. BELD will provide on-site safety personnel and engineering support at no cost to the project.

DPW: Wilson Avenue is not under moratorium. We'd recommend that the petition be granted under the normal conditions, with emphasis on the requirements that the gas main be laid outside of the trench of the water mains in service and that the trench pavement not be left low for any length of time; We also recommend that the following requirement be added to the permit, if it is to be granted:

Neither National Grid nor any of its contractors is authorized to close any street or to close a direction of travel to facilitate their work without authorization from the Director of the Department of Public Works or the Highway Superintendent. The Chief of Police can also authorize a closure for a police or fire emergency. Construction zone traffic safety issues are to be addressed by using appropriate traffic control signs and devices and the use of police officers for traffic control to safely guide traffic through the work zone. If a closure is authorized by the DPW, it shall not be implemented until signs and police officers (where needed) are properly in place in conformity with the written plan prepared by the contractor's engineer and approved by the DPW and Police Department.






