The National Grid hereby respectfully request your consent to the locations of mains as hereinafter described for the transmission and distribution of gas in and under the following public streets, lanes, highways, and places of the Town of Braintree and the pipes, valves, governors, manholes and other structures, fixtures and appurtenances designed or intended to protect or operate said mains and accomplish the objects of said Company; and the digging up and opening the ground to lay or place same:

To install and maintain approximately 860 feet, more or less of 2 inch gas main in Hillview Road, Braintree. From the existing 2 inch gas main in Hillview Road at Washington Street Westerly to House #71 Hillview Road. All of which to replace and abandon the existing 1 ½ inch gas mains in Hillview Road, Braintree.

Petition #10 025 was unanimously approved by Council with the following conditions:

DPW: Hillview Road will be in the next roadway reconstruction program, and Washington Street is being resurfaced this season, so it is good that this work is being done now. It is our recommendation that this petition **should be approved with our “standard” repair specifications, and that National Grid be advised to pursue this work through the MassDOT expeditiously.**







As part of the 2010 ACE 107 BSCSWI Program, Asset Replacement recommends the relay of approx 860 feet of 1.5 and 2 inch, 60 psig bare and coated steel (1928/1932/1940/1959) with 2 inch plastic from the exist, 2 inch coated steel at Washington St - DBRAU060 to the COM at #71.
